

PERFORMANCE MEASURES IN MAP-21

- Notice of Rule Making released in March
- > Covers 5 Performance Measures
 - Performance of Interstate
 - > Freight
 - Performance of National Highway System (non-interstate)
 - **Congestion Mitigation**
 - Mobile source emissions
- Final rule issued in January

TIMETABLE-SAFETY PERF MEASURES

Safety performance measure includes a total reduction of bicycle and pedestrians fatalities and serious injuries

Deadline	Due
August 31, 2017	States and MPOs report Initial Targets reported to FHWA
August 31, 2019	State assess and report on progress
December 2019	FHWA Assess progress



THE FUTURE OF REGULATIONS



EXECUTIVE ORDERS ON REGULATIONS

- Put all new regulations not yet implemented on a 60 day hold
 - > BUT had exemption for those required by statute
 - > Performance measures should fall under that.
 - Timeline should not be effected
- Reduce Regulations
- For every new regulation issues, at least two existing regulations must be identified for elimination."
- Those eliminated must of equal or greater cost.
- > Resource intensive...



CONGRESSIONAL REVIEW ACT

Allows Congress to retract rules, regulations and guidance passed by agencies.

- Congress must act within 60 legislative days
- > Can only do one rule or regulation at a time

Senate can do simple majority

Question of what is effected

Ocould go back to some 2009 regulations

Expecting multiple rules/regulations to be debated.



TRANSPORTATION REGS

Recent Rules that could be revoked

- Congestion Rule
- ➤ MPO rule (requiring overlapping MPOs to coordinate)
- > Trucking Hours

Not sure about rules older – Safety PM, etc?

Trump Administration

- pushing on infrastructure
- Chao 'believes he wants new fed. Investment' but 'prepared to lead DOT without new funding'

Ryan 200 day agenda

- ➤ Infrastructure added at Trump's request
- Sen. Collin's "moving along by August"



PREPPING FOR DEBATE

Lists of potential projects

- ➤ List of top 50 with Trump Administration
- National Governor's Association list/ AASHTO

Democratic Senators released plan

- > Statement of vision (vs. lists)
- Repair over replace, equity, and local control

Democratic Representatives to release plan in 2 weeks.

Main Principles

- Buy America provisions
- > Strong protects for working Americans/ Davis-Bacon prevailing wages
- Strengthen participation by minority- and womenowned businesses
- Accelerate project delivery while adhering to important environmental protections.



Rebuilding Roads and bridges- \$100 billion

- Emphasis on repair
- > Incentive funds to set and achieve perf. Measures
- Solve long –term solvency of Highway Trust Fund

Revitalize America's Main Streets-\$100 billion

- Sounds like direct aid to local govts./ Locally determined priorities
- Where bike/ped is mentioned
- ➤ Includes everything from lead in water, housing to technology

Expand TIGER

- ➤ Keep it multimodal
- > Access to jobs, generate econ. development, safety and mobility



Modernize Rail- \$50 billion

Public Transit - \$130 billion

- > \$90 billion for national repair backlog
- > \$15 billion large urgent repair / critical safety risks
- > \$30 billion replace buses and rail vehicles
- > \$45 core programing

Public Lands and Tribal Infrastructure-\$20 Billion

New Innovative Finance- \$10 billion


Question 3- Actually today, less than two percent of transportation funding goes to sidewalks, bike lanes, and trails. Seventeen percent is used for public transportation, and 80 percent is used for roads and highways. Knowing this, do you think spending on sidewalks and bikeways should increase a lot, increase somewhat, stay about the same, or decrease a lot?

Survey run by Princeton Survey Research Associates

- March 22-25, 2012 (1003 respondents)
- > September 15-18, 2016 (1000 respondents)
- > + or 3.8%



TODAY LESS THAN 2% OF TRANSPORTATION FUNDING GOES TO SIDEWALKS, BIKE LANES AND BIKE PATHS, 17% GOES FOR PUBLIC TRANSIT, AND 80% FOR ROADS AND HIGHWAYS. KNOWING THIS, DO YOU THINK SPENDING ON SIDEWALKS AND BIKEWAYS SHOULD INCREASE A LOT, INCREASE SOMEWHAT, STAY THE SAME, DECREASE SOMEWHAT OR DECREASE A LOT"












STAND OUTS

Highest support for increasing funding

- > 18-29 year olds (68%)
- > Parents (66%)
- ➤ People of Color (66%)/ Blacks (65%)

Highest for "Increase a lot"

- Income \$50-74,900 (25%)
- Democrats (24%)
- ➤ All non-whites (24%)
- Urban (24%)



CHALLENGE DEMOGRAPHICS

Less than 50% support for increasing funding

- \triangleright Those ages 65 and above (47%)*
- ➤ Republicans (44%)
- (pluralities of both said increase)

Highest support for decreasing funding

- ➤ Those with income \$50-74,900 (13%)*
- > age- 50-64 (11 %)
- ➤ Rural (11%)

Highest support for same level funding

- ➤ Republicans (42%)
- > Age- 65 years and older (38%)
- ➤ Whites (35%)



BIGGEST CHANGES SINCE 2012

Largest change in "increase funding"

- ➤ Income \$50-74,900 (22%)*
- ➤ Age 65 years and older (18%)*
- Region Midwest (17%)

Least change to "support increase in funding"

- ➤ Income \$30-49,900 (-1%)- only negative
- ➤ Northeast (3%)

Largest change to "support decrease funding"

- ➤ Suburban (-9%)
- ➤ Midwest (-8%)
- > Under \$30,000 (-8%)
